**विषय: Delegation of authorisation to M/s Airports Authority of India for performing temporary ATC duty by licensed ATCOs under Sub-rule 3(ii) of Rule 97 of the Aircraft Rules, 1937.**

महोदय,

Reference is made to AAI's letter no. AAI/CAP/2019/DGCA/4-002/AUTH/ dated 18.05.2021 corrected vide letter no. AAI/CAP/2019/DGCA/4-002/AUTH/385 dated 19.05.2021, on the subject cited above. Please also refer to this office letter of even number dated 20.04.2021 vide which competent authority has delegated certain functions to AAI related rule 97(1)- authorization of instructor/examiner; rule 97(3)-authorization of ATS personnel to provide Air Traffic Services in newly established ATS unit; rule 112(3)- appointment of examiner/board; 112(1)- conduct of examination (written/skill) etc.

2. The Competent Authority has now approved the delegation of authorisation to M/s Airports Authority of India for performing temporary ATC duty by licensed ATCOs in accordance with Sub-rule 3(ii) of Rule 97 of the Aircraft Rules, 1937 subject to strict compliance of the procedures submitted by AAI as Annexure-5 of the above mentioned letter. However deployment of an ATCO to perform air traffic control duties temporarily at an airport without endorsement of that airport on his licence may only be undertaken as a contingency measure.

3. DGCA will carry out oversight of the delegated function to ensure continuous compliance and safety all the times.

4. DGCA may withdraw or revoke the above delegation at any time if in the opinion of Director General it is necessary to do so in public interest.
